#### **Terms and Conditions of Use**

The **CovReport** is a tool to generate sequencing coverage summary for diagnostic reports (hereinafter referred to as "**the Tool**"). Details about the Tool are available on <a href="http://www.jdotsoft.com/CovReport.php">http://www.jdotsoft.com/CovReport.php</a> website page ("**the Website**"). The Tool and the Website are jointly referenced in this document as "**the Software**". You could use the Software as a guest ("**the User**").

The Software is developed and operated by the scientists of the Laboratory Marseille Medical Genetics, U1251, acting in the name and on behalf the Aix-Marseille University (AMU), the National Institute of Health and Medical Research (INSERM) and the Assistance Publique – Hôpitaux de Marseille (AP-HM), in collaboration with the JDotSoft collectively referred in this document as "the Establishments".
